Asset Building - Our Asset Building Program promotes policies and practices that enable people and communities to acquire, accumulate, and preserve financial and educational assets. In 2014 the Insight Center co-sponsored a Color of Wealth Summit attended by leading members of Congress. Our Experts of Color Network has grown to 250 professionals from all parts of the asset building field. We continue to advance significant aspects of the experts' work, such as helping to amplify the impact of the National Assets Scorecard in Communities of Color (NASCC) through the Southern Regional Asset Building Coalition. We helped to inform the thinking and research agenda of the Federal Reserve Bank in several key areas, including equitable asset building, federal tax policy, and workforce development opportunities, through meetings with and presentations before the Bank's economists. We also encouraged more integrated and aligned local procurement, investment and hiring, and philanthropy in and for Northern California through our Buy local, Invest and hire local, and Give local campaign to increase the collective impacts of leading public, private, and nonprofit institutions on regional economic vitality.

Building Economic Security for All - Our Building Economic Security for All Program promotes the use of more accurate measures of family and elder need, and uses these measures to design more effective programs and shape public policy. The Self-Sufficiency Standard for California indicates an increasing gap between family income and the amount needed for economic self-sufficiency. In 2014 the Insight Center advanced more effective uses of the Self-Sufficiency Standard and other leading alternative metrics of economic security in policy and practice. In partnership with researchers at UCLA, we released new data about the growing economic pressures facing aging Californians. The latest data inspired the formation of a coalition of aging and hunger advocates across the state known as Californians for SSI. The coalition is seeking legislative and other means to reinstate and augment state support for economically vulnerable groups across California. In concert with leading Oakland labor advocates and San Diego area human services providers, we provided data in support of campaigns leading to significant minimum wage increases in those places. We also provided information to the California Assembly on state economic security issues.

Workforce Development - Our Workforce Development Program promotes the advancement of low-wage workers, the underemployed and the under-represented through industry-focused (sector) strategies. In 2014 the Insight Center commenced a program in Northern California to secure voluntary agreements on employment equity and good jobs through a closer connection of regional companies to job-ready but significantly under-represented worker groups, including African American and Latino men and boys. Through our National Network of Sector Partners, we helped to advance the reauthorization and sector strategy focus of major new federal workforce legislation. We worked across the Deep South and along the Mississippi River with local partners on the systemic justice and employment challenges facing black men in state and local judicial systems. We assisted a workforce training consortium of community colleges along the Mississippi River to increase their responsiveness and credentialing capacities along an 8 state transportation, distribution, and logistics corridor. Our thought leadership on workforce equity issues led us to engage in national discussions on policies to promote access to good jobs, workforce diversity, and inclusion.
