

 Our mission is to help people and communities become and remain economically secure. Through our research, analysis, coalition building, and network leadership, we promote informed and inclusive decision-making for effective policy and practice, resulting in improved social and economic outcomes.

Asset Building - Our Asset Building Program promotes policies and practices that enable people and communities to acquire, accumulate, and preserve financial and educational assets. In 2017 the Insight Center focused on debt mechanisms that target and disproportionately affect communities of color. We helped identify and develop solutions at the local level in San Francisco, Baltimore and other cities to demonstrate that changes in local and state policies and practices can eliminate wealth stripping and government sponsored indebtedness. We studied the effects of credit card, medical, mortgage, and student loan debt among previously unstudied south Florida Latino groups as well as Caribbean Blacks and helped asset building and immigrant advocacy groups there gain expertise on race and indebtedness. More broadly, we analyzed the causes of racial wealth inequality, releasing a report on women's wealth that shows that a college degree fails to provide a significant return on wealth for Black women. We partnered on research demonstrating that the narratives about the importance of work when applied to communities of color with high unemployment and lower wages can lead to economic policies that exacerbate racial wealth disparities. Finally, we conducted structured interviews and focus groups with Black men in the San Francisco Bay Area to determine how arrests and convictions impact their economic well-being and their ability to accumulate wealth, and began preparing a report on millennial women and wealth.

4b (Code:) (Expenses \$ 357,049 including grants of \$ 88,500) (Revenue \$ 15,750)
Workforce Development - Our Workforce Development Program promotes the advancement of low-wage workers, the underemployed, and the under-represented. In 2017 the Insight Center continued our efforts to increase family-sustaining wages among high school dropouts and non-traditional students in Mississippi by improving educational outcomes and career-focused skills, and to support an integrated career pathways approach among Mississippi Community and Junior Colleges. We provided in-person training and shared or developed resources on employer engagement and effective work-based education and training. We provided action planning assistance to 15 community colleges and helped them share resources and lessons learned. As a result, participating students gained skills and work-related experiences that are crucial to their efforts to obtain jobs that provide economic security and move along career pathways to better jobs. Separately, we continued our efforts to address employment equity for formerly incarcerated persons, focusing on successful strategies that could be adopted by local workforce investment boards to promote fair chance hiring by local employers. Also, we continued our efforts to develop proposals that would end drivers license suspensions for failure to pay court-imposed fines and fees. Such suspensions often mean loss of employment for persons who have no other means to reach their place of work. We promoted alternative methods of establishing a reduced fines and fees standard consistent with ability to pay.

4c (Code:) (Expenses \$ 192,966 including grants of \$ 20,189) (Revenue \$ 20,486)
Health Symposium - A two-day symposium entitled "Community Agency & Health" was held in May 2017 with more than 40 presenters and approximately 150 participants. The agenda included both informational content and participatory engagement to promote active dialog and learning and to facilitate participants to commit to specific actions. The goal was to increase knowledge and capacity to improve health by fostering community agency and to build new relationships among the health sector, other sectors, and community leaders, create an environment of active learning and knowledge exchange to bring together those from diverse backgrounds & roles who do not typically convene together. Participants came from the fields of public health, healthcare, community leadership, community development, research, education, facilitation, philanthropy, housing, business, government, evaluation, social services, health finance, and health system administration. Following the symposium, a report on the symposium was prepared with lessons learned, an 11-part series was published with commentaries by presenters and participants reflecting on the symposium's impact on their work, a newsletter article was written and circulated, an article about improving community health was submitted for publication, an online tool designed to help the health sector improve its relationships with communities was launched, and a resource guide was prepared and made available online. This is a significant new program service not listed on a prior Form 990.

In 2017 the Insight Center continued our national education and engagement campaign called "Economic Security Is..." Through this work we seek to better align alternative social need metrics with progressive public advocacy and make the case for additional social investment. We also continued to assist the United Way of the Bay Area's campaign to cut poverty in half in the San Francisco Bay Area by 2020. In 2017 our Legal Program assisted community-based organizations on legal issues involved in undertaking community economic development activities.

Form 990, Part VI, Line 11b, Review of Form 990: The Form 990 was prepared by the Insight Center's Vice President Finance and Operations with information supplied by auditors and outside accounting firm, reviewed by the President and sent to the Board for review & discussion.
