Our mission is to help people and communities become and remain economically secure. Through our research, analysis, coalition building, and network leadership, we promote informed and inclusive decision-making for effective policy and practice, resulting in improved social and economic outcomes.

**Asset Building - Our Asset Building Program promotes policies and practices that enable people and communities to acquire, accumulate, and preserve financial and educational assets. In 2015 the Insight Center continued our co-sponsorship of a Color of Wealth Summit attended by leading members of Congress. Our Experts of Color Network received training on strategic messaging on issues of race and assets. With key members of the Network, we continued to support the National Assets Scorecard in Communities of Color (NASCC) initiative. The NASCC data on race, place, and wealth highlights the economic status of people of color in the U.S., breaking down large groups into subgroups with a focus on localities and regions. We helped to produce a series of reports on race and wealth, including Bootstraps Are For Black Kids; Race, Wealth, and the Impact of Intergenerational Transfers on Adult Outcomes; and Umbrellas Don't Make It Rain: Why Studying and Working Hard Isn't Enough For Black Americans. Looking at retirement security, we released the first in a series of reports on the importance of planning for retirement. We co-sponsored community forums on retirement planning for households and businesses of color and partnered with the PBS series Moneywise to produce nationally televised segments on retirement planning. Also, we supported the release of a report on minority and women business enterprise opportunities in public contracting processes, and released a book and created a website on asset building in Latino communities.**

**Workforce Development - Our Workforce Development Program promotes the advancement of low-wage workers, the underemployed and the under-represented through industry-focused (sector) strategies. In 2015 the Insight Center continued our efforts to secure voluntary agreements on employment equity and good jobs that address the needs of companies and job-ready, but significantly under-represented, worker groups, especially African American and Latino men and boys. We focused on health care sector opportunities in Northern California, with exploratory discussions in Chicago and Boston. Our thought leadership on workforce equity issues led to our participation at key regional gatherings, including conferences in New York City, Atlanta, and Chicago. Our other sector strategy work included training and technical assistance to Goodwill Industries and their community college partners on career pathways, and providing training and technical assistance on developing sector partnerships to nine community colleges along the Mississippi River. We also guided Oakland's Workforce Investment Board's development of strategies and funding to support sector partnerships. Additionally, we worked with the Lawyers' Committee for Civil Rights Under Law to address employment equity legal issues affecting traditionally hard-to-employ populations, and provided technical assistance to Career Access, a network of disability community leaders and advocates concerned about employment issues affecting disabled workers.**

**Building Economic Security for All - Our Building Economic Security for All Program promotes the use of more accurate measures of family and elder need, and uses these measures to design more effective programs and shape public policy. In 2015 the Insight Center launched a national education and engagement campaign called "Economic Security Is..." Through this work we seek to better align alternative social need metrics with progressive public advocacy and make the case for additional social investment. Over 300 leaders concerned about these issues participated in a webinar we organized on new opportunities to galvanize public support. Also in 2015, we completed a regional study of economic security strategies in collaboration with United Way of the Bay Area to help advance their campaign to cut poverty in half in the San Francisco Bay Area by 2020. We analyzed the effect on economic security of varying levels and configurations of social investments in education, healthcare, transportation, and nutritional support. Our report includes recommendations and a roadmap for further study and action. Finally, we advanced our work on California elder advocacy, focusing on the growing public benefit needs of seniors. We testified before a joint committee of the California Assembly on Who Can Afford to Get Old? Senior Poverty in the Golden State.**
