A national economic justice organization, Insight helps people and communities become and remain economically secure. With a particular focus on race, gender, and place in the pursuit of impactful economic change, we work to build inclusion and equity for people of color, women, immigrants, and low-income families. Through research, advocacy, narrative change, and thought leadership, we promote informed and inclusive decision-making for effective policy and practice, resulting in improved economic outcomes.

Workforce Development - Insight focuses on activities that help low-income people access jobs that pay well, have career ladders, and are high quality with benefits and opportunities. Insight conducts research and outlines solutions that ensure working people can thrive. In 2020, Insight continued our efforts to advance the well-being of Mississippians disconnected from employment and education, focusing on Black and low-income persons in certain counties. Following our examination of regional labor markets, the workforce system, barriers to work, and structural factors such as occupational crowding, we released a report on the two-tiered labor market in Mississippi and the national implications. In addition to our work in Mississippi, we published a study that examines ways in which workforce institutions in the San Francisco Bay Area may be perpetuating racial and gender bias and inequities, and continued our efforts in the San Francisco Bay Area to address employment equity for formerly incarcerated persons. We addressed the corona virus pandemic by publishing a brief and holding a podcast on the impact of the pandemic on New Orleans' workers, we published a brief that documents the loss of business by race due to the pandemic, and published a brief on the impact of the pandemic on vulnerable workers in California. Finally, we connected these efforts with our larger advocacy to eliminate harmful court fines and fees, and other policies and practices that perpetuate racial and gender inequities in the workforce development system.

4b (Code:) (Expenses \$ **302,234** including grants of \$ **0**) (Revenue \$ **30,540**)

Economic Security - Insight is a national leader in advancing ideas and solutions that address the root causes of economic exclusion. We promote the use of more accurate measures of family need, and use these measures to design more effective programs and shape public policy. In 2020, Insight secured funding for an updated California Family Needs Calculator (formerly Self-Sufficiency Standard) and promoted the newly updated Calculator to workforce development boards, law and policy advocates, philanthropic investors, and government officials across California. We used the Calculator's data to train San Francisco Bay Area stakeholders on the roots of the area's racial inequities, including disparities across health, housing, childcare, and criminal justice. Through our involvement with the Truth and Justice in Child Support Coalition, we helped get legislation passed that will benefit more families who interact with the child support system. Following up our co-released The Payback Problem: How Taking Parent's Child Support Payments to Pay Back the Cost of Public Assistance Harms California's Low-Income Children and Families, we undertook further efforts to change state and local policies that unfairly take child support payments from families. Finally, we continued to assist the United Way of the Bay Area's campaign to cut poverty in half in the San Francisco Bay Area.

Asset Building - Insight promotes policies and programs that help close the gap in assets between rich and poor communities, women and men, people of diverse races and ethnicities and recent immigrants and the U.S. born, enabling people and communities to acquire, accumulate, and preserve financial and educational assets. In 2020, Insight continued its efforts that focus on debt mechanisms targeting and disproportionately affecting communities of color. We worked in a coalition to help enact the California Families Over Fees Act, which ended the assessment and collection of 23 criminal legal administrative fees in the state and expunged an estimated \$16 billion of debt. We made presentations on the racial wealth gap, the status of women and wealth, and the need for funders to support policies and programs aimed at advancing wealth equity. In total, we presented research and new frameworks to over 1,500 advocates and policymakers, including a new framework to implement racial equity strategies in addressing economic exclusion. We released a case study on student equity solutions for two colleges in the Working Student Success Network. We analyzed and discussed in various forums universal basic income strategies to address poverty and racial equity. Finally, we addressed the corona virus pandemic by publishing articles in major media outlets about the impact of the pandemic on women and communities of color.
